The Restrictions of this Declaration shall run with and bind the land subject to this Declaration for a term of ten (10) years from the date that this Declaration is recorded.

This Declaration shall be irrevocable and may not be removed, revoked, amended or changed, in whole or in part, by Declarant; it being intended hereby that this Declaration is being made under and in compliance with the provisions of Section 23.81, et seq., of the Property Tax Code of the State of Texas pertaining to Recreational, Park and Scenic Land and that this Declaration and the Restrictions are and shall be enforceable by owners of property which is adjacent to the Property.
